SQUARE DEAL SPORTSMEN, INC. • RANGE SAFETY AND GROUND RULES

If you do not fully understand any of the Rules and Regulations, or require further explanation, it is **YOUR RESPONSIBILITY** to contact a member of the Board of Directors for clarification

GENERAL SAFETY RULES

- 1. Treat' every firearm as if it is loaded until you have personally proven otherwise.
- 2. Always point the muzzle of the firearm in a safe qirectlon, down range, or in the air. No cross-range shooting.
- 3. Keep your finger off the trigger until ready to shoot.
- 4. Be sure of your target and what is beyond
- 5. Keep the action open and the firearm unloaded, except when on the firing line ready to fire. Firearms will not be handled when anyone is forward of the firing line. All firearms will be benched or racked and made safe. No one will go forward of the firing line until the 'all clear' has been agreed on.
- **6. Dangerous use of firearms will not be tolerated.** Any indiscriminate handling or shooting of semi-automatic firearms, or use of firearms so as to cause a hazard to fellow members, guests, club· property, and/or neighboring property will be subject for dismissal from the club.
- 7. Eye and ear protection is recommended and is the responsibility of all persons on all ranges.
- 8. Know your firearms and ammunition. Have only proper ammunition on the firing line for the firearm you are using.
- 9. Know, obey and understand all the range commands and range terminology. On the command "CEASE FIRE', immediately-bench and make safe all firearms.

RANGE AND PROPERTY USAGE

- 10. Shooting hours on all ranges are from 9:00 am until SUNSET. Sunset time Is the time posted in the local newspaper for that day.
- 11. Absolutely <u>NO</u> discharging of firearms on the property other than on designated ranges and in the direction of the safty berm down range. The only exception is for members using the grounds for hunting of turkey and deer in season, and ONLY with a club-issued permit.
- 12. Only pistols and 22 caliber rifles are allowed to be fired on the pistol ranges.
- 13. Frames and target stands set up for a specific use (e.g.: Silhouette Range, IPSC cardboard/steel) shall not be used for general shooting or used to affix other targets to.
- 14. Shooting of **clay pigeon targets is restricted** to shotgun type rifles only, and only on the club's ranges. **Bowling pin** shooting is allowed on the pistol ranges.
- 15. Only approved targets are to be used on all ranges. Approved targets will be paper, cardboard or NRA-approved steel. No glass, cans, cinder blocks, rocks, plastic jugs, trees, etc.
- 16. No tracer, incendiary, explosive, fragmentation, armor-piercing bullets, fireworks or explosive targets are permitted. In addition, no firearm or cannon may be discharged at the club if the bore Is larger than 1.00 inch in diameter.

- 17. Except as authorized, licensed or unlicensed ATV or snowmobile operation, horses, and bicycles are prohibited on Club grounds.
- 18. No fires except in designated areas or burn barrels unless given specific written permission from the Club. 19. All members are asked to pick up their trash, empty cartridges, casings, brass, and hulls. Barrels and buckets are supplied for that purpose. Any brass left behind belongs to the Club and is not to be taken for personal use by any Club member. To do so will be considered theft and grounds for expulsion from the Club.
- 20. The *running of hunting dogs* for training purposes is acceptable as long as this activity does not interfere with the normal use of the shooting ranges and is done within the constraints of all local and state laws.

GENERAL MEMBERSHIP RULES

- 21. Any member identified as being in violation of the Range Safety Rules may be subject to suspension or expulsion.
- 22. Guests of regular members are limited to ONE visit only, then guest must join Club, or member must purchase a Guest Membership.
- 23. Alcohol, controlled substances, or any other means used to get 'high', contained in or on the person or in any vehicle is NOT allowed on the property.
- 24. No power equipment is to be operated on the property unless two people are present at all times. Operation of the Club's vehicles for any purpose is only with prior permission of the Board.
- 25. No Club property shall be removed from the grounds without the permission of the Board of Directors. Use of the Club property (grounds, buildings & equipment) by committees or outside groups must be approved by the Board.
- 26. Small game hunting; and taking of squirrel, wing birds, etc. by any means, is allowed on Club property. In season, Big Game and Turkey hunting is also allowed. All hunting on Club grounds requires obtaining a Club-issued permit (Limited Hunting Permit) from the Board of Directors.

PLEASE READ CAREFULLY. These rules are based on the honor system. By your signature below, you are indicating that you have read and understand them in their entirety and that you acknowledge that any failure to comply will be grounds for expulsion.
